Sanjay Kumar Agarwal takes charge as CBIC Chairman

- IRS officer Sanjay Kumar Agarwal has taken charge as the Chairman of the Central Board of Indirect Taxes and Customs (CBIC). Agarwal succeeds Vivek Johri who superannuated as CBIC chief on May 31. In an order issued on August 5, the finance ministry had appointed Agarwal, who was holding charge of CBIC member compliance management, looking into investigations.
- The CBIC, which deals with policy making in indirect taxes -GST, customs, excise - is headed by a chairman and has six members in the board. The board is assisted by principal chief commissioners/chief commissioners and principal director generals/ director generals.



About the Central Board of Indirect Taxes and Customs (CBIC) -

- The Central Board of Indirect Taxes and Customs (CBIC) is a statutory body under the Ministry of Finance, Government of India. It is responsible for the administration of indirect taxes in India, which include customs, central excise, service tax, and goods and services tax (GST). The CBIC also has the responsibility of preventing tax evasion and smuggling.
- The CBIC was established in 1947, following the independence of India. It was originally called the Central Board of Revenue (CBR). The CBR was responsible for the administration of all taxes in India, including direct taxes and indirect taxes. In 2000, the CBR was split into two boards: the Central Board of Direct Taxes (CBDT) and the CBIC. The CBIC took over the responsibility of administering indirect taxes.
- The CBIC is headed by a Chairman, who is an Indian Revenue Service (IRS) officer of the rank of Additional Secretary to the Government of India, The Chairman is assisted by a number of members, who are also IRS officers. The members are responsible for different areas of work in the CBIC, such as customs, excise, service tax, and GST.
- The CBIC has a number of offices located all over India. The headquarters of the CBIC is located in New Delhi. The CBIC also has regional offices, zonal offices, and field formations.
- The CBIC is a very important organization in the Indian government, It is responsible for collecting a significant amount of revenue for the government. The CBIC also plays a vital role in preventing tax evasion and smuggling.

Justice Subhasis Talapatra sworn in as new Chief Justice of Orissa High Court

- Justice Subhasis Talapatra was officially appointed as the 33rd Chief Justice of the Orissa High Court. The oath of office was administered by Governor Ganeshi Lal, marking his succession of Justice S Muralidhar.
- He is set to hold the position of Chief Justice for a relatively short period of under two months, concluding with his retirement on October 3, 2023.
 - Justice Talapatra's Judicial Journey: From Tripura to Orissa High Court -
- Born on October 4, 1961, in Udaipur, Tripura, Justice Talapatra began his judicial journey.
- He assumed the role of a judge in the Tripura High Court on September 13, 2013, having previously served as an additional judge in the same court from November
- In 2018 and 2019, he had the honor of temporarily holding the position of acting Chief Justice of the Tripura High Court on two occasions.
- He was transferred to the Orissa High Court as a judge on June 1, 2022, where he officially took the oath of office on June 10, 2022.

Nomination of Justice Talapatra for Chief Justice of Orissa High Court by Supreme Court Collegium -

- Justice Talapatra's nomination for the role of Chief Justice of the Orissa High Court was put forth by the Supreme Court Collegium, under the leadership of Chief Justice of India DY Chandrachud.
- The Collegium of the Supreme Court is composed of the five most senior judges, including the Chief Justice of India, Their responsibilities encompass evaluating the promotion of Chief Justices and Judges of High Courts to the Supreme Court, the promotion of High Court Judges to Chief Justices, and the elevation of Judges.

Tesla appoints India-origin Vaibhav Taneja as its CFO

- Indian-origin Vaibhav Taneja has been named Tesla's new Chief Financial Officer as the previous finance chief Zachary Kirkhorn announced his decision to step down. He was appointed Tesla CFO in addition to his current role as Chief Accounting Officer (CAO) of the US-based electric car major after Kirhom, Tesla's Master of Coin and finance chief for the last four years, stepped down from the post.
- Mr Kirkhorn's 13-year tenure with the Elon Musk-led American EV giant was described as one of "tremendous expansion and growth" in the company filing.

After the former Chairperson Justice A.K Goel retired in July, Justice Sheo Kumar Singh was appointed as the Acting Chairperson. Justice Srivastav Enrolled as Advocate on February 2, 1987. He Practised on Tax, Civil and Constitutional sides in the Supreme Court of India at







New Delhi. He was later appointed as a Judge of the High Court of Madhya Pradesh on January 18, 2008 and became a permanent Judge on January 15, 2010.

Life and Career of Prakash Shrivastava -

Justice Shrivastava was born on March 31, 1961. In the year 1987, he was enrolled as an advocate and practiced in tax, civil, and constitutional law, at the Supreme Court. Later, he was appointed as an additional judge at the Madhya Pradesh High Court on January 18, 2008 before being made permanent on January 15, 2010. Subsequently, Justice Shrivastava served as the Chief Justice of



Calcutta High Court from October 11, 2021 till his retirement on March 30, 2023.

- The National Green Tribunal (NGT) is a specialized body set up by the Government of India under the National Green Tribunal Act, 2010 to provide speedy and effective justice to cases related to environmental protection and conservation of forests and other natural resources. It is a quasi-judicial body with powers to hear and decide cases relating to environmental pollution, environmental degradation, and other matters affecting the environment.
- The NGT has its headquarters in New Delhi and has five zonal benches located at Bhopal, Pune, Kolkata, Chennai, and Guwahati. 

About the Udyog Ratna award -





Reserve Bank of India (RBI) Introduces Reforms for Transparent Home Loan EMIs

In a significant move aimed at enhancing transparency and consumer protection in the home loan sector, the Reserve Bank of India (RBI) has introduced a comprehensive set of reforms pertaining to floating rate home loans. These reforms are designed to bring more clarity to the process of resetting interest rates, offer borrowers the option to switch to fixed interest rates, and prevent banks from unilaterally changing the loan tenure without proper consent.



The RBI's reforms emphasize the need for banks to establish a transparent framework for resetting interest rates on floating rate home loans. Regulated Entities, including banks, are now required to:



- Clearly communicate with borrowers about potential changes in tenor and Equated Monthly Installments (EMIs).
- Provide borrowers the flexibility to switch from floating to fixed interest rate loans or foreclose their loans.
- Disclose all charges associated with exercising these options.
- 4. Ensure effective communication of essential information to borrowers.
 - These measures are expected to bolster consumer protection and improve transparency within the lending process.

Addressing Unreasonable Tenure Changes:

A concern highlighted by the RBI was the undue elongation of loan tenures by lenders without obtaining proper consent or communication from borrowers. Instances where loan tenures were extended to over 30 years without borrower consent have been observed. To counter this issue, the RBI is implementing a conduct framework for all Regulated Entities.

Wholesale Price Deflation Narrows to 1.36% in July, Driven by Food Price Spike

- Wholesale prices in July contracted by 1.36% after a 4.12% deflation in June. Despite overall deflation, food and primary article prices surged by over 7.5%, reducing the dip from June's low,
- In July, the Wholesale Price Index (WPI) continued to exhibit deflationary trends for the fourth consecutive month, although the decline was notably mitigated by a substantial increase in food and primary article prices. While the overall WPI deflation shrank from June's 92-month low of -4.1% to -1.36%, a surge of over 7.5% in food and primary article prices played a pivotal role in this shift.

Food and Primary Article Inflation Surges :

Primary food article inflation reached an impressive 14.3% in July, marking its highest level in nearly a decade.

The surge in vegetable prices was particularly striking, with an 81.1% spike compared to June and a 62.1% increase from the previous year. Other staples like milk, wheat, cereals, pulses, and paddy saw year-on-year price hikes of over 8% to 9%.

Mixed Trends Within Food Category:

While several food items experienced substantial price escalations, potatoes and fruits saw declines of 24.4% and 8.9%, respectively, in comparison to last July. However, the price of potatoes did increase by 8% from June. Onions, too, witnessed a notable price increase of nearly 28% since June 2023 and 7.13% from July 2022.



Retail Inflation Surges to 15-Month High of 7.44% in July

In July, retail inflation in India experienced a significant upswing, reaching 7.44%, marking the highest rate since April 2022. This surge contrasts with the preceding four-month period of inflation below the central bank's 6% tolerance threshold. The increase is largely attributed to an 11.5% spike in food prices, making it the first time since September 2022 that the price rise has crossed the 7% mark.

Food Price Surge Drives Overall Inflation:

- Retail Inflation Surges to 15-Month High of 7.44% in July
 - The primary driver of the July inflation surge was an impressive 11.5% increase in food prices, causing a ripple effect on the overall inflation rate. Notably, vegetable prices surged by a staggering 37.3%, while cereals and pulses became over 13% more expensive. Consequently, urban consumers saw their food bills rise by over 12.3%, while rural consumers experienced an 11% increase in food inflation. On the whole, rural residents faced a slightly higher overall inflation rate of 7.63% for the same period.





Consumer Price Index and Food Price Dynamics:

The Consumer Price Index (CPI) rose by 2.9% from the previous month, reflecting the swift inflationary pressures. The month-on-month increase in food prices was notable as well, with a 6.7% upsurge. These figures surpassed the expectations of most economists.

Implications for the Economy :

The sudden surge in inflation poses challenges for the central bank's projections and policy decisions. The 7% inflation rate for two consecutive months raises questions about the possibility of triggering action from the Reserve Bank of India (RBI). Bank of Baroda's chief economist, Madan Sabnavis, points out that while the probability of an interest rate hike remains low, it cannot be ruled out entirely.



RBI's August 2023 Monetary Policy Meeting Highlights

RBI's August 2023 Monetary Policy meeting highlights encompass the RBI's decisions, economic assessments, inflation forecasts, and policy measures discussed during the August 2023 Monetary Policy Meeting.

Repo Rate Unchanged at 6.5%:

- The Reserve Bank of India (RBI) has maintained the repo rate at 6.50% during its August 2023 monetary policy meeting.
- The decision was taken unanimously by the sixmember Monetary Policy Committee (MPC).



- Headline inflation, which dropped to 4.3% in May 2023, experienced a rise in June and is expected to further surge in July and August due to higher vegetable prices.
- The RBI has projected India's Q2 retail inflation at 6.2%, Q3 at 5.7%, and Q4 at 5.2% for the current fiscal year.
- The CPI inflation forecast for FY2023-24 has been revised from 5.1% to 5.4% due to shocks in vegetable prices.

Economic Outlook: 3.

- Despite weak external demand, domestic economic activity remains robust and is likely to maintain its momentum.
- The RBI has retained the GDP growth forecast for the fiscal year at 6.5%, with balanced risks.
- Monitoring Inflation Trajectory:
- The MPC remains committed to aligning inflation with the target of 4% and anchoring inflation expectations.
- The cumulative rate hike of 250 basis points implemented by the MPC is gradually affecting the economy.
- The MPC decided to stay vigilant and assess the evolving situation before making any policy changes.

5. Liquidity Measures :

The RBI has instructed banks to maintain an incremental cash reserve ratio of 10% on the growth in deposits between May 19 and July 28, effective from the August 12 fortnight.

6. **UPI Payment Updates:**

- The RBI announced changes in UPI payments, allowing offline payments using near-field communication.
- The payment limit via UPI Lite has been increased from Rs 200 to Rs 500.

7. Transition to Fixed-Rate Regime :

Home loan and other borrowers are permitted to switch to a fixed-rate regime, according to the RBI's directive.

8. Consistent Policy Stance :

- This marks the third consecutive monetary policy meeting in which the MPC has chosen to keep the reporate unchanged at 6.50%.
- Previously, the MPC had increased the repo rate by 250 basis points from May 2022 to February 2023.

9. Positive Indian Economic Outlook:

RBI Governor Shaktikanta Das noted that the Indian economy remains a bright spot in the global landscape.

Digital payments grew significantly at 13.24% in FY23, shows RBI index

In the fiscal year 2022-2023 (FY23), digital payments in India experienced remarkable growth, as indicated by the Reserve Bank of India (RBI) Digital Payments Index (RBI-DPI). The RBI-DPI, a comprehensive measure of payment digitization, displayed a substantial increase across all parameters during this period, driven by significant advancements in payment infrastructure and performance across the country. The index for March 2023 recorded a value of 395.58, marking a 13.24% growth compared to September 2022 (377.46), as announced on January 31, 2023.



RBI-DPI's Growth Trajectory -

The RBI-DPI began with a base index value of 100 in March 2018 and has been consistently rising ever since. It provides a reliable gauge of the extent of digital payment adoption in India and is updated semi-annually, with a four-month lag.

Key Parameters of RBI-DPI -

The RBI-DPI encompasses five major parameters, each representing crucial aspects of the digitization of payments. These parameters are:

- Payment Enablers: This parameter evaluates the factors that facilitate digital payment adoption, such as the availability of digital wallets, mobile banking services, and internet penetration.
- Payment Infrastructure Demand Side Factors: Focusing on the consumers' end, this parameter examines the accessibility and ease of using digital payment platforms, including point-of-sale (POS) devices and payment gateways.



- Currently, the UDGAM portal provides access to unclaimed deposit information from seven banks, including prominent names like State Bank of India, Punjab National Bank, South Indian Bank, Central Bank of India, Dhanlaxmi Bank, DBS Bank India, and CitiBank N.A. For other banks, the search feature will be introduced in phases by October 15, 2023.

Registration Process on UDGAM Portal -

- Getting started with the UDGAM portal is a straightforward process. Follow these steps to register and initiate your search for unclaimed deposits:
- 1. Visit the Portal: Head to the UDGAM portal.

India's first Solar Mission Aditya L1 to be launched soon

The Indian Space Research Organisation (ISRO) is launching its first solar mission, Aditya-L1, to study the Sun. The mission will be placed in a halo orbit around the Lagrange point 1 (L1), which is about 1.5 million kilometers from Earth. From this vantage point, Aditya-L1 will be able to study the Sun's atmosphere, magnetic fields, and space weather impacts.

Mission Overview -

- Halo Orbit Placement: Aditya-L1 is designed to be positioned in a halo orbit around the L1 Lagrange point, ensuring a stable vantage point for continuous solar observations.
- Launch and Deployment: The mission will be launched using the ISRO PSLV rocket from the Sathish Dhawan Space Centre SHAR (SDSC SHAR) in Sriharikota. The spacecraft will initially be placed in a low Earth orbit,







- which will then be transformed into an elliptical orbit before reaching L1 using on-board propulsion.
- Cruise Phase and Halo Orbit: As the spacecraft journeys towards L1, it will exit Earth's gravitational sphere of influence, marking the commencement of the cruise phase. Once at L1, it will enter a vast halo orbit around the Lagrange point.

Mission Objectives -

Solar Upper Atmospheric Dynamics: Aditya-L1's primary objective is to study the dynamic behavior of the Sun's upper atmosphere, including the chromosphere and corona. The mission seeks to understand processes like chromospheric and coronal heating, and the initiation of solar eruptive events.




- Space Weather Impact: By observing solar activities and their impact on space weather in real-time, the mission aims to contribute to the understanding of solar events like coronal mass ejections (CMEs) and their influence on Earth's space environment.
- Particle and Plasma Environment: Aditya-L1 will provide valuable data on particle dynamics from the Sun, contributing to the study of solar wind, particle propagation, and the partially ionized plasma in the solar atmosphere.

Payloads and Scientific Instruments -

- VELC (Visible Emission Line Coronagraph): This payload will focus on studying the corona through imaging and spectroscopy, along with observing coronal mass ejections.
- SUIT (Solar Ultraviolet Imaging Telescope): SUIT will capture images of the photosphere and chromosphere, measuring solar irradiance variations and facilitating narrow and broadband imaging.







Aditya-L1 Mission to be Launched in September

- Indian Space Research Organisation's (ISRO) Chief S Somanath announced that Aditya-L1 mission, the first space-based Indian observatory to study the Sun will be likely launched by the first week of September. This announcement comes hours after ISRO's third lunar mission Chandrayaan-3 made a successful landing on the lunar surface.
- Aditya L1 will be ISRO's 2 space-based astronomy mission after AstroSat, which was launched in 2015. Aditya I was renamed as Aditya-L1. The Aditya I was meant to observe only the solar corona.



What is AstroSat?

AstroSat, was launched in September, 2015, by PSLV-C30 from Sriharikota (Andhra Pradesh). It is the first dedicated Indian astronomy mission aimed at studying celestial sources in X-ray, optical and UV spectral bands simultaneously.

About the Aditya L1 -

Aditya L1 would be the first space-based Indian mission to study the Sun. The spacecraft shall be placed in a halo orbit around the Lagrange point 1 (L1) of the Sun-Earth system, which is about 1.5 million km from the Earth. A satellite placed in the halo orbit around the L1 point has the major advantage of continuously viewing

the Sun without any occultation/eclipses. This will provide a greater advantage of observing the solar activities and its effect on space weather in real time. Earlier, on July 14, ISRO, taking to Twitter informed that Aditya-L1, the first space-based Indian observatory to study the Sun was getting ready for the launch.

Key Points -

- Launch Vehicle: Aditya L1 will be launched using the Polar Satellite Launch Vehicle (PSLV) XL with 7 payloads (instruments) on board.
- Objective: Aditya L1 will study the Sun's corona (Visible and Near infrared rays), Sun's photosphere (soft and hard X-ray), chromosphere (Ultra Violet), solar emissions, solar winds and flares, and Coronal Mass Ejections (CMEs), and will carry out roundthe-clock imaging of the Sun.
- Challenges: The distance of the Sun from Earth (approximately 15 crore kms on average, compared to the only 3.84 lakh kms to the Moon). This huge distance poses a scientific challenge. Due to the risks involved, payloads in earlier ISRO missions have largely remained stationary in space; however, Aditya L1 will have some moving components which increases the risks of collision. Other issues are the super hot temperatures and radiation in the solar atmosphere. However, Aditya L1 will stay much farther away, and the heat is not expected to be a major concern for the instruments on board.

Important

- Evolution of every planet, including Earth and the exoplanets beyond the Solar System, is governed by its parent star i.e the Sun in our case. The Solar weather and environment affects the weather of the entire system. Therefore, it is important to study the Sun.
- Effects of Variation in Solar Weather System: Variations in this weather can change the orbits of satellites or shorten their lives, interfere with or damage onboard electronics, and cause power blackouts and other disturbances on Earth.

- Notably, this operation was characterized by meticulous planning and confidence rarely seen in the Indian subcontinent.
- Many armed volunteers were ex-servicemen or former Assam Regiment personnel dismissed for disciplinary
- The rebels besieged the headquarters of 1 Assam Rifles, released prisoners, looted arms and funds, and declared independence.







Government's Response : Overcoming Resistance :

- Brigadier Rustom Zal Kabraji led ground operations to clear rebelheld positions. He commanded the 61 Mountain Brigade based in Agartala.
- Despite efforts to resupply the Assam Rifles battalion via helicopters, rebel resistance led to the shooting down of some supply missions.
- The ground operations faced formidable opposition, requiring several days to reach Aizawl.

IAF's Role in the Conflict: Air Power Takes Center Stage :

- The Indian Air Force (IAF) was called upon as the Army struggled against the rebels.
- Initially, the IAF focused on re-supplying army installations using Dakotas and Caribou transport aircraft from Guwahati and Jorhat.
- During one such mission, a Dakota aircraft sustained 21 bullet holes but managed to land at Kumbhigram air base near Silchar.
- This incident triggered offensive air operations.
- The 29 Squadron operated the Toofani (Dassault Ouragan), stationed at Bagdogra, while the 14 Squadron flew Hunters from Jorhat.
- Actual air missions commenced on March 5, contributing significantly to regaining control over previously independent territories.



Union Cabinet Approves PM-eBus Sewa Scheme: Boosting Electric Public Transportation

In a significant move towards enhancing urban transportation and promoting electric mobility, the Union Cabinet has given its nod to the "PMeBus Sewa" scheme. This initiative is aimed at expanding city bus operations by deploying 10,000 electric buses through a Public-Private Partnership (PPP) model.

Union Cabinet Approves PM-eBus Sewa Scheme: **Boosting Electric Public Transportation**

Scheme Cost and Support: The PM-eBus Sewa scheme is projected to incur a total cost of Rs 57,613 crore. To facilitate its implementation, the Central government will provide financial support

of Rs 20,000 crore. The scheme's scope extends over a period of 10 years.



- Coverage Criteria: The scheme will encompass cities with a population of three lakh and above as per the 2011 census, including capital cities of Union Territories, the North Eastern Region, and Hill States. A notable emphasis will be placed on cities lacking organized bus services.
- Direct Job Creation: Implementation of the scheme is projected to result in the creation of 45,000 to 55,000 direct job opportunities. This will be accomplished through the deployment of approximately 10,000 buses for city bus operations.
- Segment A: Augmenting City Bus Services: One segment of the scheme, labeled Segment A, is dedicated to enhancing city bus services across 169 cities. This component will primarily focus on expanding the availability of electric buses for urban transportation.
- Segment B: Green Urban Mobility Initiatives (GUMI): The second segment, Segment B, targets 181 cities and revolves around green mobility initiatives. These include the implementation of bus priority measures, development of multimodal interchange facilities, integration of NCMC-based Automated Fare Collection Systems, establishment of charging infrastructure, and more.

- Operational Framework: The responsibility of operating the bus services and making payments to bus operators will rest with the respective states and cities. The Central Government's role will involve extending subsidies as outlined in the scheme to support these operations.
- Promoting E-Mobility: The scheme places a strong emphasis on promoting electric mobility. It provides substantial support for the creation of necessary behind-the-meter power infrastructure. Additionally, cities will receive assistance for establishing charging infrastructure as part of Green Urban Mobility Initiatives.

India announces 'Green' Hydrogen standard

- India has announced the definition of Green Hydrogen. The Green Hydrogen Standard for India sets a criterion of 2 kg CO2 equivalent per kg H2 as a 12-month average emission threshold. It is a significant move for the progress of the National Green Hydrogen Mission. The guidelines established by the Ministry of New and Renewable Energy (MNRE), Government of India, delineate the emission benchmarks that must be fulfilled for hydrogen production to qualify as 'Green', signifying its origin from renewable sources.
- The Ministry of New & Renewable Energy has characterized Green Hydrogen as having a well-togate emission (encompassing processes like water
 - treatment, electrolysis, gas purification, hydrogen drying, and compression) that does not exceed 2 kg CO2 equivalent per kg H2.
- The scope of the definition encompasses both electrolysis-based and biomass-based hydrogen production methods. The notification explicitly states that the Ministry of New & Renewable Energy will define a comprehensive methodology for measuring, reporting, monitoring, on-site verification, and certifying green hydrogen and its derivatives. Bureau of Energy Efficiency (BEE), Ministry of Power shall be the Nodal Authority for accreditation of agencies for the monitoring, verification and certification for Green Hydrogen production projects.





ISRO-developed device for fishers' safety successfully tested at Neendakara

The Indian Space Research Organisation (ISRO) has achieved a significant milestone by successfully testing its innovative device named 'Nabhmitra'. This device, developed at ISRO's Space Applications Centre in Ahmedabad, aims to enhance the safety of fishermen during their sea expeditions. The successful testing took place at Neendakara, where the device was installed on a fishing vessel, and its capabilities were assessed in the presence of both scientists and officials from the Fisheries department.









- ISRO-developed device for fishers' safety successfully tested at Neendakara
- Nabhmitra operates on the basis of advanced satellite communication technology, allowing seamless two-way







messaging between fishing boats and maritime authorities stationed at sea. This breakthrough technology greatly improves the communication channels and safety measures available to fishermen during their voyages.

ISRO's Nabhmitra device: Key Features and Functions -

- Weather and Cyclone Warnings: The device facilitates the transmission of critical weather updates and cyclone warnings to fishing boats in the local language. This enables fishermen to stay informed about potentially hazardous conditions and make informed decisions regarding their operations.
- 2. Distress Messages: Fishermen can now send distress messages to the authorities in case of emergencies. Whether facing challenges like capsizing or fires, fishermen can activate the distress signal with a single button press, immediately alerting the control center about their situation.
- Emergency Connectivity: Upon receiving a distress signal, the control center is immediately notified, including the precise location of the distressed fishing boat. Simultaneously, the boat's crew receives a response message from the control center, assuring them that help is on the way.
- Navigational Assistance: In addition to safety features, Nabhmitra also serves as a valuable navigational tool. It provides vital information about shipping channels and maritime boundaries, assisting fishermen in navigating safely through often challenging waters.
- Fishing Field Identification: The device's capabilities extend beyond safety concerns. Nabhmitra aids in the identification of fishing fields, contributing to more effective and productive fishing operations.

India, Asian Development Bank to set up climate change and health hub in Delhi

- India is now all set to open a climate change and health hub in the national capital Delhi in partnership with the Asian Development Bank (ADB). Earlier, India had bagged the first WHO Centre for Global Traditional Medicine. WHO Centre for Global Traditional Medicine was set up in Jamnagar, Gujarat.
- The new hub for climate change and health will facilitate knowledge sharing, promote partnerships and innovations, and also help countries beyond the G-20, especially developing countries. In its recently released G-20 outcome document, India also noted that climate change will continue to drive health emergencies, including the emergence



and re-emergence of infectious diseases, and by increasing the severity and frequency of natural disasters, thereby threatening to overwhelm health systems' ability to deliver essential services.

The outcome document committed to :

- Prioritize climate-resilient health systems development, build sustainable and low-carbon/low greenhouse gas (GHG) emission health systems and healthcare supply chains that deliver high-quality healthcare, mobilize resources for resilient, low-carbon sustainable health systems, and
- Facilitate collaboration, including initiatives such as the WHO-led Alliance for Transformative Action on Climate and Health (ATACH). The new Climate Change and Health Hub in New Delhi will help countries all over the world to address to identify new drivers and address the existing drivers using a science and risk-based approach, and to strengthen existing infectious disease surveillance systems.

China's Economy Slips into Deflation: Implications and Countermeasures

Deflation, the inverse of inflation, signifies a persistent decline in the general price levels of goods and services within an economy. The recent occurrence of deflation in China, the world's second-largest economy, has triggered concerns about its economic prospects and the need for robust policy responses from Beijing.

Understanding Deflation -

Deflation can be succinctly described as a continuous reduction in overall price levels across an economy. This situation contrasts with inflation, where prices increase over time. In China's case, both the consumer price index (CPI) and producer price index (PPI) reported declines in July.



- Consumer Price Index (CPI) Decline: China's CPI dipped by 0.3 percent year-on-year in July, marking its first decrease since February 2021.
- Producer Price Index (PPI) Decline: The PPI experienced its tenth consecutive monthly decline, falling by 4.4 percent, surpassing the predicted 4.1 percent decrease.
 - These statistics underscore the mounting economic challenges confronting China.

Causes of Deflation in China -

- Deflation can stem from multiple factors, such as reduced consumer demand, an oversupply of goods, technological innovations that lower production costs, or stringent monetary policies by central banks. In China's context, the primary drivers of deflation are diminished consumer demand and an economic slowdown.
- Reduced Consumer Demand: When consumers anticipate further price drops, they tend to delay purchases. This leads to decreased demand for goods and services.
- Economic Slowdown: China's economic deceleration has contributed to the decline in consumer spending, amplifying deflationary pressures.

Implications of Deflation -

- While falling prices may initially seem advantageous to consumers, deflation can yield detrimental effects on the economy, mirroring China's predicament.
- Negative Demand Cycle: Deflation can initiate a damaging cycle. Anticipated price decreases prompt consumers to postpone purchases, leading to reduced demand, lower production, decreased business revenues, potential layoffs, and a subsequent decline in consumer spending.
- Economic Contraction: The cyclical reduction in economic activity can intensify, causing a downward spiral marked by economic contraction, job losses, and financial instability.

- Global Temperature Soars

The global average temperature for July 2023 shattered previous records, soaring 0.72°C above the July average of 1991-2020. This temperature increase was a significant 0.33°C higher than the previous hottest month, July 2019. Furthermore, July 2023 was estimated to have been approximately 1.5°C warmer than the historical average from 1850-1900. These figures emphasize the rapid escalation of global temperatures.

Northern Hemisphere Heatwaves

he Northern Hemisphere bore the brunt of extreme heat, with widespread heatwaves affecting various regions. Southern Europe, in particular, experienced scorching temperatures. The occurrence of such



heatwaves indicates the concerning intensification of climate anomalies in recent years.

South America and Antarctica Affected

Across South America, numerous countries witnessed well-above-average temperatures. Meanwhile, significant warming was observed around a substantial portion of Antarctica, indicating the broad-reaching impact of global temperature trends.

3. Disturbing Sea Surface Temperature Rise

Sea surface temperatures also surged to alarming levels, building upon a period of high temperatures since April 2023. In July, global average sea surface temperatures reached a record high, surpassing the 1991-2020 average by 0.51°C. Distinct regions, including the North Atlantic, experienced temperature spikes of 1.05°C above the norm. Marine heatwaves were observed in the Caribbean basin, the Mediterranean Sea, and the seas surrounding Greenland.

2023's Warming Trend

The year 2023 emerged as the third warmest year to date, with an overall temperature elevation of 0.43°C compared to the recent average. July's global temperature was an astounding 1.5°C above preindustrial levels. This dramatic increase underscores the need for immediate and substantial efforts to curtail greenhouse gas emissions, which remain the primary driver of these unprecedented climate records.

Sea Ice Retreat

The decline of sea ice continued in July 2023, particularly in Antarctica, where the sea ice extent reached a remarkable 15% below average. This unsettling trend has persisted for several months, painting a dire picture of the ongoing impacts of climate change. While Arctic sea ice extent remained slightly below average, it remained well above the record low observed in July 2020.

Hydrological Changes

- July 2023 brought varying hydrological conditions across the globe. Northern Europe and regions from the Black Sea to northwestern Russia experienced above-average rainfall. Conversely, the Mediterranean basin faced drier-than-average conditions, with Italy and southeastern Europe witnessing notable anomalies.
- Outside of Europe, areas such as northeastern North America, Afghanistan, Pakistan, northeastern China, northern and eastern Australia, and Chile received above-average rainfall. On the other hand, regions such as Mexico, the southwestern United States, central and southeastern Asia, southwestern Australia, and parts of southern Brazil and Paraguay experienced below-average precipitation.

Australia to be testing ground for US missiles

Australia's involvement in the AUKUS (Australia, United Kingdom, United States) pact has gained attention due to its potential role as a testing ground for advanced hypersonic and long-range precision weapons. The agreement, initially focused on supplying Australia with nuclear-powered submarines, has evolved to address the growing influence of China in the Asia-Pacific region. U.S. Secretary of the Army Christine Wormuth highlighted Australia's unique contributions and the collaborative nature of the pact.

Australia's Non-Monetary Contribution -

While Australia's involvement in AUKUS includes the exchange of advanced defense technologies, Secretary







Wormuth emphasized that its contribution doesn't solely revolve around financial commitments. Australia's strategic geographical attributes, including vast distances and sparsely populated land, make it an ideal testing ground for cuttingedge weaponry.

AUKUS Pact and China's Influence -

The AUKUS pact, signed in late 2021, serves as a strategic response to counter China's increasing dominance in the Asia-Pacific region. By enhancing Australia's defense capabilities, the pact aims to create a deterrent against potential aggression from China, a stance that has been criticized by Beijing but strongly supported by the pact's member nations.



Evolution of AUKUS Focus -

Initially centered on the acquisition of nuclear-powered submarines, the AUKUS pact has broadened its scope to include advanced technologies such as long-range precision firing, artificial intelligence, and hypersonic weapons. The pact's evolution reflects the partners' commitment to staying at the forefront of defense innovation and adapting to emerging threats.

Iraq bans media from using term 'homosexuality'

- The Iraqi Communications and Media Commission (CMC) has enforced a ban on the use of term 'homosexuality', instead mandates using the term 'sexual deviance' as a replacement.
- The media regulatory body of Iraq has issued a prohibition on the usage of the term 'homosexuality' instructing both media and social media entities to employ the term 'sexual deviance' in its place.

Ban on Specific Terms for Media and Internet Companies in Iraq -

This directive encompasses all media and social media establishments functioning within the country, as specified by the Iraqi Communications and Media Commission (CMC).



The use of these terms in any of their applications is now prohibited for all licensed CMC phone and internet companies. As a result, these companies are constrained from including "homosexuality" or "gender" in any of their mobile apps.

Complexities Surrounding LGBTQ+ Rights in Iraq and Recent Developments -

- In recent times, loosely defined morality provisions within Iraq's penal code have been utilized to single out LGBTQ+ individuals.
- In the past couple of months, significant Iraqi factions have intensified their opposition to LGBT rights, frequently exemplified by the burning of rainbow flags in protests led by Shiite Muslim factions, who are expressing their disapproval of recent Koran burnings in Sweden and Denmark.

LGBTQ+ Discrimination in Iraq and Global Legal Context -

- LGBTQ+ individuals face extensive discrimination in Iraq, with open homosexuality leading to military service bans and the illegality of same-sex marriages or civil unions
- These individuals lack legal safeguards against discrimination, often falling victim to vigilante justice and honor killings.
- While gay sex is not explicitly criminalized, Iraq's anti-LGBT stance dates back to its declaration of independence, during which homosexuality was officially prohibited.



BRICS Welcomes New Members: Inclusion of Argentina, Iran, UAE, Saudi Arabia, Ethiopia, and Egypt

In a significant geopolitical development, the BRICS alliance, comprising Brazil, Russia, India, China, and South Africa, has announced the inclusion of six new member countries. This expansion marks a notable shift in the alliance's composition and has the potential to reshape the dynamics of global cooperation.

BRICS's New Members: Bridging the Global South -

President Cyril Ramaphosa of South Africa, the host nation of the recent BRICS summit, made a historic announcement on August 24th, revealing the names of the new entrants to the alliance. The



expanded BRICS now welcomes Argentina, Iran, the United Arab Emirates, Saudi Arabia, Ethiopia, and Egypt into its fold. This move not only diversifies the alliance but also provides a platform for emerging economies from different regions to align their interests on the global stage.

The BRICS summit saw South African President Ramaphosa extend an invitation to Indian Prime Minister Narendra Modi to address the assembly. He also took the opportunity to highlight India's remarkable strides in space exploration and research, emphasizing its commitment to technological advancements.

Complexities of Inclusion: Pakistan's Absence and China's Stance

China's prior push to include Pakistan within the BRICS alliance had introduced a diplomatic quandary, adding complexity to the proceedings. China's reasoning behind this proposition stemmed from its belief that BRICS should encompass a wider membership to represent a broader range of developing nations. However, this idea faced resistance, particularly from India. The opposition was rooted in concerns that an enlarged BRICS could dilute the alliance's core objectives and potentially weaken the consensus among its original members.



ISRO's next mission to Moon is with Japanese, named LUPEX

Indian Space Research Organisation (ISRO) is preparing for one more lunar mission, this one in collaboration with Japanese space agency, The Japan Aerospace Exploration Agency (JAXA). This mission, called LUPEX, or Lunar Polar Exploration, is slated for 2024-25. But there would be more in the Chandrayaan series as well, LUPEX will offer ISRO another opportunity to probe the surface of the Moon.

About the LUPEX -

As its name suggests, LUPEX will also explore the polar regions of the Moon, this time venturing into the permanently shaded regions. One half of




the Moon never faces the Sun, and is therefore permanently dark. To land in these areas, the spacecraft and the onboard instruments have to have an alternative power supply option through an onboard battery. LUPEX is also planned to investigate the abundance of water in the polar regions, and explore the possibilities of locating a long-term station in these areas. For the LUPEX mission, the launch vehicle and rover are supposed to be contributed by the Japanese agency, while the lander will come from ISRO. Incidentally, JAXA is sending its own landing mission, its first, to the Moon later this week.

The immediate priority for ISRO is the Aditya-L1, its first mission to the Sun, which is slated for an early September launch. Aditya-L1, referred to by Prime Minister Narendra Modi in his address today, will observe the Sun from a distance of 90 million km. It is meant to study the different kinds of phenomena like solar corona, solar emissions, solar winds and flares, and coronal mass ejections. It will also do an imaging of the Sun.

- Defending Formula One champion Max Verstappen emphatically won the Belgian Grand Prix for an eighth straight win and 10th overall of a crushingly dominant season. He finished 22.3 seconds ahead of teammate Sergio Perez to give Red Bull and easy 1-2. It moved Verstappen ominously closer to a third straight world title and his own F1 record of 15 wins from last year.
- Ferrari driver Charles Leclere finished in third spot for a third podium of the season, with Lewis Hamilton in fourth for Mercedes ahead of Aston Martin's Fernando Alonso. George Russell was sixth for Mercedes, with Lando Norris (McLaren), Esteban Ocon (Alpine), Lance Stroll (Aston Martin), and Yuki Tsunoda (AlphaTauri) completing the top 10.



Aishwary Pratap Singh Tomar clinches Gold medal at FISU Games

- Aishwary Pratap Singh Tomar, along with compound archers Avneet Kaur, Sangampreet Singh Bisla, and the men's 10m air rifle team, achieved remarkable victories by securing gold medals at the FISU World University Games 2023 in Chengdu, the People's Republic of China.
- With these achievements, India's medal tally at the FISU World University Games 2023 reached an impressive total of 17 medals - nine gold, three silver, and five bronze. India currently holds the fourth position on the medals table, trailing behind China, Japan, and the Republic of Korea.





- The Indian team celebrated the exceptional performance of shooter Aishwary Pratap Singh Tomar, who notched not one but two gold medals during the competition. Following his triumph in the men's 50m rifle 3 positions event, Aishwary continued his brilliant form by claiming the top spot in the men's 10m air rifle team event.
- In the finale, Aishwary scored an impressive total of 252.6 points, securing victory over his fellow Tokyo Olympian and compatriot, Divyansh Singh Panwar, who settled for the silver medal with 251 points. The bronze in the event was bagged by China's Buhan Song, who scored 229 points.
- Indian Trio Clinches Gold Medal in Men's 10m Air Rifle Team Event with Remarkable Team Spirit
- The Indian trio comprising Aishwary Pratap Singh Tomar, Divyansh Singh Panwar, and Arjun Babuta showcased exceptional team spirit, resulting in a gold medal for the men's 10m air rifle team event.
- The team displayed remarkable coordination and skill, earning a combined score of 1894.7 points. China followed closely behind with a silver medal and a score of 1881.9, while Kazakhstan secured the bronze with 1878.2 points.

GM Gukesh overtakes Viswanathan Anand to become highest Indian in FIDE rankings

- The 17-year-old chess prodigy, D. Gukesh, has dethroned Grandmaster Viswanathan Anand as India's top-ranked chess player in the live world rankings. Gukesh achieved this feat by defeating Mistradin Iskandarov in the second round of the FIDE World Cup, reaching a live rating of 2755.9 and climbing to the 9th position in the classic open category. In contrast, Anand's rating of 2754.0 caused him to drop to the 10th spot. This is only the second time since 1986 that Anand has been displaced from the top position.
- Gukesh's recent gain of 2.5 rating points pushed his
- live rating to 2755.9, while Anand's rating remains at 2754.0. As a result, Gukesh is now ranked as the 9th best chess player in the world, and Anand stands at 10th place. Anand had held the top position in India's chess rankings since January 1987 and has been one of the country's most prominent players since July 1991.
- Gukesh, who recently became the youngest player to reach a live rating of 2750, is determined to break the 2800-mark. Despite this significant achievement, Gukesh is currently focused on his upcoming match against fellow Indian player S. L. Narayanan in the World Cup. Celebrations for his achievement will have to wait as he prepares for the next round.



Chess World Cup 2023 Final: India's Praggnanandhaa finishes 2nd

Rameshbabu Praggnanandhaa finished second in FIDE World Cup. After three days and four games of intensely nervy chess across two formats, Magnus Carlsen finally managed to win the FIDE World Cup for the first time in his career. Carlsen defeated Praggnanandhaa in the final, but not before the 18-year-old teenage had dragged him through the tie-breaker. Carlsen's win was confirmed after the second game of the tiebreaker. The two players had played out one draw each.







Praggnanandha, who turned 18 during the World Cup, was the youngest World Cup finalist ever, and is the youngest World Cup winner. Seeded 31, Pragg is also the lowest seed to make the final of the World Cup. Praggnanandhaa became a GM at the age of 12. He was going strong before the COVID-19 pandemic hit, which brought the world to a standstill. But the Chennai teenager made the most of it, homing his skills in online tournaments.

About the Rameshbabu Praggnanandhaa -

 Rameshbabu Praggnanandhaa (born 10 August 2005) is an Indian chess grandmaster. A chess prodigy, he became an international master at the age of 10, the youngest at the time to do so, and a grandmaster at the age of 12, the



second-youngest at the time to do so. On 22 February 2022, at the age of 16, he became the youngest player to defeat thenworld champion Magnus Carlsen, when he beat Carlsen in a rapid game at the Airthings Masters Rapid Chess Tournament (a record since broken by Gukesh D, on 16 October 2022).

HS Prannoy Clinches Bronze At BWF World Badminton Championships 2023

Indian badminton player HS Prannoy secured the bronze medal in the men's singles category at the prestigious BWF World Badminton Championships 2023. Despite a valiant effort, Prannoy was eliminated in the semi-finals that took place in Copenhagen, Denmark on Saturday. His remarkable journey in the tournament showcased his skill and determination on the international stage.

A Tough Match Against Kunlavut Vitidsarn -

 World No. 9 HS Prannoy faced a formidable challenge in the semi-finals as he went head-to-head with Thailand's Kunlavut Vitidsarn, ranked third in the badminton world. The intense match stretched



over one hour and 16 minutes at the Royal Arena. Prannoy fought valiantly but was eventually edged out by his Thai counterpart with a scoreline of 21-18, 13-21, 14-21.

A Historic Achievement -

The 31-year-old HS Prannoy etched his name in Indian badminton history by becoming only the fifth Indian men's singles player to clinch a medal at the BWF World Badminton Championships. Among his compatriots, Kidambi Srikanth remains the sole player to reach the men's singles final, achieving this feat in 2021.






The bomb was dropped by the B-29 bomber Bockscar, commanded by Major Charles Sweeney. The bomb exploded over Nagasaki at 11:02 am local time, killing an estimated 80,000 people instantly and another 35,000 people from radiation exposure in the following months. Fat Man was a plutonium implosion bomb, and it was much more powerful than the uranium bomb that was dropped on Hiroshima. The blast from Fat Man was equivalent to 21 kilotons of TNT, which is about 13 times more powerful than the Hiroshima
- The bombing of Nagasaki was a turning point in the war. The Japanese government was already considering surrender, but the bombing of Nagasaki convinced them that they could not continue the war. On August 15, 1945, Japan surrendered to the Allies.
- The atomic bombings of Hiroshima and Nagasaki were a horrific event, and they are a reminder of the destructive power of nuclear weapons. However, they also played a role in ending the war in the Pacific, and they helped to save countless lives.

9 August – International Day of the World's Indigenous Peoples

Every year International Day of the World's Indigenous Peoples is celebrated on 9 August to encourage people from around the world to spread the UN's message on the protection and promotion of the rights of indigenous peoples.
